Cancellation Policy: In order to terminate your membership, you must complete a cancellation form in person and pay the \$40 Cancellation Fee. Any balance on your account must be paid before the cancellation process can be completed. If you request to cancel a "1-year commitment" membership, prior to the end of 12 months of being an active member, you will be charged an additional cancellation fee of \$100.

Open Gym Memberships are non-refundable and non-transferable after the membership is purchased. Your recurring membership payment will automatically be charged every month, and will continue to be automatically charged after 12 months, until you complete a cancellation form in person. All members understand that classes have priority to space and equipment in the facility.

Premium Memberships are non-refundable and non-transferable after the membership is purchased. Your recurring membership payment will automatically be charged every month, and will continue to be charged after 12 months, until the member completes a cancellation form in person. Any classes that are included in your monthly Premium Membership that are not used within 1 month, will expire and they will be removed from your account.

After 12 months of being an active member, your membership will automatically continue to be charged every month unless you fill out a cancellation form. If your monthly payment for any membership is declined for any reason, you are subject to a \$10 processing fee.

Personal Training Sessions become non-refundable and non-transferable after the first session of the package is used. These sessions will expire after 12 months from the sale date and are non-refundable. Any scheduled session that the authorized member fails to attend or cancels within 24 hours of the session will be forfeited by the member and the session will not be refunded.
